RULES & REGULATIONS

- 1. Contest is open to anyone purchasing a ticket in Alberta with the exception of those less than 18 years of age and the 2019 CF Hockey Draft of Hope Committee members and their immediate families.
- 2. There is no limit to the number of entries per person.
- Only those players on the entry form are eligible to be selected and no substitutions will be allowed.
- Completed entry forms will be accepted provided that valid payment is included, tickets are still available, tickets are completed correctly and received prior to <u>5 p.m. on Wednesday, April 10th, 2019.</u>
- 5. All sales received are final and non-refundable. No refunds will be issued, except in the event that the draft is cancelled.
- If more than 20 players are selected, only the first 20 players will be accepted. Once received: no additions, deletions or changes will be permitted. For online ticket purchases only, player selections can be edited up until the entry deadline.
- Each goal or assist scored by those selected players during the playoffs will count as one point. Points will be based upon official NHL statistics only.
- Any ties will be broken first by total goals and second by highest plus/minus score. If still tied after this process, the available prize money will be split equally but no prize will be less than \$25.00.
- 9. If a player does not play for any reason or plays below expectations, no compensation will be made.
- The Hockey Draft standings will be updated at least biweekly on the website. Standings will be published in The Edmonton Sun at the conclusion of the Stanley Cup Playoffs.

Please include your ticket number in all correspondence. An independent accounting firm will investigate any unresolved entrant complaints.
- 12. Following the publication of winners' names in The Edmonton Sun, other entrants have 14 days to challenge the results. Any such enquiries should be sent to the address given in Rule #11.
- 13. Prizes will be awarded on approximately May 1/19 for the 1st round, May 15/19 for the second round, May 29/19 for the third round and June 12/19 for the 4th round. Winners will be notified by mail and cheques will be sent to their entry form address. Winners have one year from the draw dates in Rule #13 to claim their prize. After that date and with AGLC approval, any unclaimed prizes would revert to Cystic Fibrosis.
- 14. There is no limit to the number of prizes per entrant, but all prizes must be accepted as awarded. By entering the 2019 CF Hockey Draft of Hope, entrants agree to the use of their names.
